

AFTERNOON EXPRESS LINDT HAMPER COMPETITION – TERMS AND CONDITIONS

- The Afternoon Express Lindt Hamper competition ("the Competition") will be run by Cardova Trading Proprietary Limited (registration number: 2010/007686/07) ("the organisers") and the prizes are provided by Lindt & Sprüngli (South Africa) (Proprietary) Limited (Registration: 2011/001971/07) ("the Promoters").
- By entering the Competition entrants agree to be bound to all the terms and conditions and competition rules as set out herein.
- The Competition is open to all South African citizens and permanent residents of South Africa who permanently reside in the Republic of South Africa, except directors, members, partners, employees, agents of, or consultants to the organisers, Promoters or any other person who directly or indirectly controls or is controlled by the organisers or Promoters, including their immediate family, business partners or associates, or any supplier of any goods or services in connection with the Competition.
- Entrants under the age of 18 must be assisted by a parent/legal guardian, who approves of, and consents to the entrant's possession and use of the prize, should he/she be selected as winner.
- The competition will open on Friday, 21 August 2015 at 06h00 and close on Thursday, 27 August 2015 at 00h00 ("the competition period").

The hampers can only be won by following these instructions. This must be done within the Competition period.
- Only entries received during the competition period will be considered for the competition.
- The winners will be selected at the discretion of the judges. They will receive the prize under the condition that they fulfilled all requirements of the competition.
- There is no restriction on the number of entries, provided that each entry is a unique entry (e.g. not re-posts of the same entry). Entrants may enter as many times as they like to increase their chances of winning.

- No automated entries will be allowed and all entries must be made by a natural person manually the blogs.

- If any entry was made in a manner which in the organiser's discretion may provide an entrant with an unfair advantage over other entrants, unless these rules specifically allow such conduct, such entrant will be disqualified from this and all future competitions run by the organisers.

- Entrants will be required to attend to the cost for their entry, including standard internet costs.
